OFFICIAL RULES 2026 “I VOTED” STICKER CONTEST FOR MIAMI COUNTY HIGH SCHOOL STUDENTS

By submitting an entry, participants agree to be bound by these Official Rules.

1. SPONSOR

The Miami County Clerk & Elections Office sponsors this contest.

2. ELIGIBILITY

- Must be a resident of Miami County, Kansas
- Must be currently enrolled in grades 9-12, or the equivalent for home-schooled students

3. HOW TO ENTER

- Each entry must be submitted individually (if multiple submissions) with a completed release form. There is no limit to the number of entries students or schools may submit.
- Submit artwork, completed entry form, and completed release form.

4. RECOGNITION

- The Board of County Commissioners will recognize the contest winner at its meeting on July 15th, 2026, meeting held at 1 pm at the Miami County Administration Building.
- The winning drawing will be printed as the Official Miami County Election sticker which will be handed out during the 2026 Primary and General Elections.

ENTRY DEADLINE IS 4:30 PM on THURSDAY, APRIL 30, 2026!

5. DESIGN REQUIREMENTS

- Artwork must be submitted on the official template which is two-dimensional- 6” round.
- Artwork must be nonpartisan and may not advocate for or against any political party, candidate, or issue. Artwork must not include anything obscene or inappropriate for general audiences.
- Artwork must be original, may not include copyrighted images or trademarks, and must not infringe upon the rights of privacy, publicity, or any other rights of any person.
- Submitted artwork becomes the property of the Miami County Election Office.
- The design must include the phrase “I Voted in Miami County”
- Designs should reflect the theme of voting and elections in Miami County, the State of Kansas, or the United States.

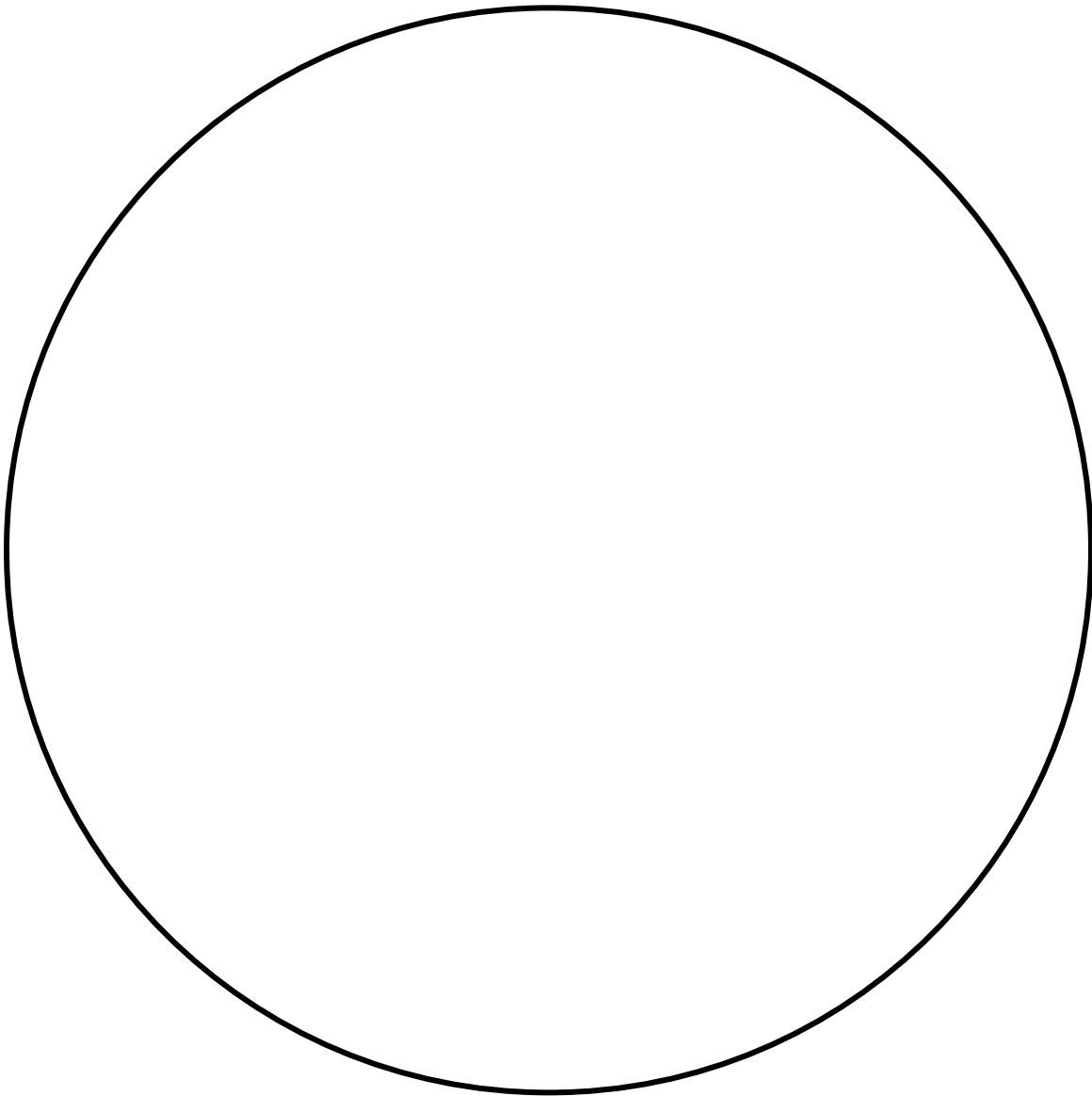

OFFICIAL “I VOTED” STICKER DESIGN CONTEST PARENTAL CONSENT FORM

By signing this Parental Consent Form:

1. I hereby agree that my minor child may participate in the “I Voted” Sticker Design Contest hosted by the Miami County Election Office (“Sponsor”), and irrevocably grant my permission and authorize the Sponsor to use my minor child’s name, school, artwork, likeness and photograph in advertising, marketing, and promoting the contest, and to reproduce and publish the same locally, nationally and internationally, in perpetuity, in any and all media now known or hereinafter devised. I further agree that the contest, my minor child’s participation in the contest and all of the contest elements belong entirely and exclusively to the Sponsor, so that the Sponsor and its licenses and assigns may duplicate, distribute, broadcast, exhibit, or otherwise use the contest without limitation or restriction locally, nationally and internationally, in perpetuity. The Sponsor may edit and adapt my child’s participation as it deems appropriate.
2. I understand and agree that neither I nor my minor child will own any rights in the contest or the contest elements or receive any monetary compensation relating thereto. I am granting the Sponsor a free, non-exclusive, irrevocable license to use my minor child’s name, school name, artwork, likeness and photograph to fulfill the purposes of the contest. I acknowledge that the Sponsor shall have no obligation at all to use my minor child’s information in the contest.
3. I agree that neither I nor my minor child shall make any claims against the Sponsor based upon distribution or exploitation of the material or the contest and its elements to which I have consented on behalf of my minor child. I release the Sponsor and its licensees and assigns from any and all claims and liabilities whatsoever that may occur in relation to or arising from my minor child’s participation in the contest. I agree that this consent and release will be governed by and construed in accordance with the laws of Kansas.
4. I confirm that my minor child lives in the United States of America, State of Kansas, and Miami County, Kansas.
5. I agree that my minor child may participate in the contest described in the Official Rules at [miamicountyks.gov] and is permitted to accept the prizes awarded to the winners.
6. I understand my minor child’s name and other information that I provide on behalf of or related to my minor child, as described in the Official Rules, may be posted together with my minor child’s submission upon the Sponsor’s website and social media platforms, as well as other public forums, such as the media, without any additional notice to or permission by me.
7. I hereby warrant that I am a legally competent adult and a parent or legally appointed guardian of the minor child named below, and that I have every right to contract for the minor child in the above regard.
8. I certify and acknowledge that I have read, understood and agree to the Official Rules of the contest, and that I have read this Parental Consent Form prior to signing it; that I have the full authority to give my consent and release so that my minor child may participate in the contest and that I consent to provide the information concerning my minor child that is necessary to enter the contest and if selected, to be awarded a finalist, runner-up, or winner.

Accordingly, and intending to be legally bound, I voluntarily agree to the terms set forth herein and acknowledge and agree that my minor child and myself are bound by the Official Rules and I am bound by the terms of this Parental Consent Form. This release shall be binding upon minor child, me, and our respective heirs, legal representatives, and assigns.
